

Customers Feedback – What we heard?

- Workflow is complex and click heavy
- More here:



Main changes to addressed these pain points:

- New unified task list
 - Set to prevent users from the need to 'Go to task list' when searching for PO lines in various statuses
- New 'side-by-side' presentation
 - Allows users quick review and edit of PO line information as well as navigating to related workflows without losing focus on the origin point.








Slide panel to overlay origin point

What's in it for you?

- Seamless workflow
- Task list as facets no extra step in order to "Go to task list"
- Multi-select facets focus on what you need faster
- Clearer information hierarchy- find what they need faster and with less navigation needs
- "Side -By-Side" presentation complete your tasks faster with less navigational needs
- "Slide-Out" panel for extra information single page application experience and a clear sense of orientation
- Resolve numerous pain points raised by the community



Customers Feedback – What we heard?

- Workflow is complex and click heavy [New unified list]
- Need an end-to-end workflow that 1 person can do in 1 go [New unified list]
- Searching for POL is very slow [New unified list]
- Note to vendor field should move up in the screen and not 'under the fold' [New unified list / Future Enhancement]
- Quantity for pricing is not reflecting ordered items [February release]
- POL status 'waiting for manual renewal' is confusing [April release]
- Invoice line (tab) has an invoice number but is not clickable [February 2021 release]
- Add next to the 'list price' a 'local price' (make the exchange) [New unified list]
- EDI task list no clear indication which library is the owner (POL owner) [January release]
- Have the PO line internal note searchable [April release]
- 'Currency' field presents all options and not only these which are configured to the vendor [Roadmap]
- Not enough fields are saved in the template [Roadmap]
- When viewing the POL's which were created via the import process (advanced search), there are no facets this make the error handling process harder [New unified list]
