SLSP network: Ca. 500 affiliated libraries in 31 Institutions zones (Iz) with 30 Mio. records and 50 Mio. items in a multilingual environment

3. Guiding principles



Guiding Principles

Guide the decision-making process

Ensuring the evolution of Discovery tools aligned with user needs, technological advancements, and institutional priorities

Support the team decision process from small to big matters

Internal tool for the Discovery team

When a decisions or the analysis of a proposal, project, idea, configuration, a rule/standard is needed, those principles are checked.

Usability, Accessibility and Diversity

Usability and accessibility must be ensured. Diversity is respected. Possibilities to improve usability and accessibility are actively investigated. Any feature, element, decision or customization that compromises usability or accessibility, is excluded.

Measurement User UX and Accessibility tests (internal or external), Analysis software, UX and Accessibility standards and rules (WCAG for instance)

Simplicity and Sustainability

Simplicity and minimalism lead the decision process. Any feature, element, customization, decision or adjustment that leads to overcomplexity, or unsustainable resource need, is excluded.

Measurement Needed efforts in maintenance of views, Internal available resources, User UX and Accessibility tests (internal or external).

Data & Analytics

Data and Analytics inform and guide decisions on implementations and changes. All ideas, features, decisions, and customizations are grounded in solid data and analytics.

Measurement User UX and Accessibility tests (internal or external), Analytics and data collection tools

Innovation and Evolution

Continuous improvement through updates and releases are performed, as well as adoption of emerging technologies, providing they do not conflict with other strategic pillars.

Measurement Comparing similar tools from other communities or other industries.

Uniformity

Uniformity and personalization must be balanced. Any feature, element, customization, configuration or decision pursue the uniformity of the user experience within swisscovery views, while considering libraries local needs.

Measurement SLSP Configuration and customization rules, User UX and Accessibility tests (internal or external).

Universality

The SLSP community must benefit from the undertaken work. The entire SLSP community must (potentially) profit of every feature, element, customization, configuration or implemented decision. Specific solutions are in principle excluded.

Measurement Possibility to use every solution in local views.

Advantages and limits

Clear and simple

Explicit what was implicit

Applicable to every decision to be taken

Increase the transparency

Subjectivity

Systematic and strict usage of the principles
